Lighthouse Charter School relied heavily on the input received by the community and school stakeholders for the development of the Local Control and Accountability Plan from the groups required under ESSER III. These stakeholder meetings took place on 5/25/21 and 6/1/21. The LCAP was also reviewed, and stakeholder feedback was solicited at public meetings of the Governing Board on 6/7/21 and 6/21/21. In the development of the Local Control and Accountability plan, school leadership anticipated a full return to in-person learning and planned accordingly. Leadership also continues to seek input from parents and community members through regular check-ins by the principal with stakeholder groups and regular meetings of the governing board.

The plan was submitted to the Governing Board on October 18, 2021 for review, discussion, and approval.

In line with the additional community member consultation requirements outlined in the ESSER III instructions, school administration contacted all families and representatives of the following groups during the week of October 11, 2021 to gather feedback regarding the plan as applicable, including, Students, Families, including families that speak languages other than English, School and district administrators, including special education administrators, Teachers, principals, school leaders, other educators, school staff, and local bargaining units, Tribes, Civil rights organizations, including disability rights organizations, Individuals or advocates representing the interests of children with disabilities, English learners, homeless students, foster youth, migratory students, children who are incarcerated, and other underserved students.

The Governing Board also held a public hearing on October 18, 2021 to gather any additional feedback from groups that did not submit earlier written feedback before adopting the final ESSER III Plan.

#### A description of how the development of the plan was influenced by community input.

The community has placed a strong emphasis on in-person learning. A small number of families continued to want a distance learning option, which the school was happy to provide to keep our community safe. Our community has also expressed a strong desire to return to the academic programs that existed before closures due to the pandemic, including project based learning, art and music. The community also expressed a desire to increase the academic rigor for all students. The plans presented here provide the teachers with the academic support and coaching necessary to bring back the high quality academic and specials programs.

The basis of our plan was built upon the knowledge gained through our annual LCAP process of identifying school and student needs and receiving stakeholder feedback on the development of ensuing goals and actions. From the external community partners one of the biggest need they identified is increased mental health and behavioral needs of students. This shaped our section "use of any remaining funds" to include increased social emotional learning and mental health supports for our students. Our school community stakeholder feedback echoed this request for more mental health opportunities for our students.

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
